Ken's presentation can be found in the attached Power Point. Some of the highlights are included here:

- a. Covanta's Huntington Plant opened in 1991
- b. Involved in the destruction of prescription medication
- c. The World's leading energy to waste company
- d. Thermal destruction is the only way to ensure that prescription drugs are disposed of properly
- e. The power generated from the Towns of Smithtown and Huntington garbage gets to power on a grid.
- f. Individuals cannot come to Covanta to dispose of drugs. Difference between community vs. commercial programs.
- g. 4 billion prescriptions written in 2016 in the U.S.
- h. We only have 23 million people in the country
- i. 12.5 prescription per individual in US
- j. 280 million prescriptions written in NY. That's 15 prescriptions per individual in NYS
- k. Ground water contamination is a major concern as on Long Island our water comes from the ground
- I. Waste water treatment plants cannot help with this
- m. 80% of all rivers tested by US geological survey show traces of pharmaceutical products
- n. Landfilling is not an option
- o. Can lead to contamination from run-off and leachate sources
- p. 1983 landfill law lead to the elimination of landfills in 1990
- q. 28 out of 61 wells in Suffolk came back positive for pharmaceutical products
- r. Cholesterol, birth control, antibiotics, anti-depressants, pain killers are among the medications found in the well water tested
- s. Take back program through Covanta is called Rx4Safety
- t. First program launched in 2010
- u. Provides for safe and secure destruction of medications

v. Force prescription companies to have an interest in the proper disposal of leftover prescriptions. Example, If they paid a penny per persecution, the take back would be funded forever
